June 27th, 2007 – Minutes

George White of Hughes Parker hosted the meeting and provided lunch. Old Business

- Minutes from the May meeting were not available.
- Diane Ezell provided information on options for the balance in the treasury. After discussion, Kristie Hagan made a motion to place \$5000 in a 6-month, 5% interest bearing CD. The interest would be added back to the CD. The balance of the funds would be placed into a money market account. Andy McCormick seconded the motion. Beth Keaton will make the changes to the treasury funds.
- This month, the Lawrence County Safety Council assisted a member, Lawrenceburg Utility Systems, with the purchase of Natural Gas Safety Handbooks from the National Safety Council. Because of the affiliation of the Lawrence County Safety Council with the National Safety Council, the training materials were able to be provided to LUS at a significantly reduced cost.
- The October Safety Conference dates have been tentatively set for October 15th and 16th. Columbia State Community College (Lawrenceburg campus) will allow us to use their facilities again this year. During this meeting, the group briefly discussed potential programs to be offered. Andy McCormick will schedule a sub-committee meeting in the next couple of weeks for the conference planning group to begin selecting the programs to be offered this year.

New Business
